To be eligible you must be physically located or applying to work within the Berkshire Taconic region which includes NW corner of Litchfield county 2 Salisbury, North Canaan, Canaan, Norfolk, Sharon, Cornwall, Goshen, Kent, Warren), Connecticut, NE corner of Dutchess County Dover, Pine Plains, Millerton, Stamford, Amenia, Millbrook, Washington), NY, Berkshire County, MA, and Columbia County, NY.

All applications will be graded on ideas, not grant writing ability.

BIPOC means Black, Indigenous, or People of Color this includes but is not limited to African Americans, Native Americans, people from the African or Latin diaspora that identify as people of color.

We fund powerful, community-rooted projects led by those most impacted. This grant supports nonprofits, collectives, and individuals with bold visions for equity.

We believe in trust, transparency, and shared integrity—so while we keep things accessible, we also honor our responsibility to the community and to each other.

The committee meets on a monthly basis to review applications and make decisions. From there all recommended grants are still subject to Berkshire Taconic staff and board approval. Once approved it takes two weeks to receive a check. Please keep this timeframe in mind while applying.,
